Approval of Minutes: Minutes of 5/3/18 CEC Meeting **APPROVED** with changes – Unanimous

Welcome & Introduction:

KH announces that Gloria Villanueva will assist with elections training. He met with Staci Decker, Kendall County Elections Administrator, to discuss issues with the election. Many people did not know where to vote, and there was a problem with the e-poll books at the Precinct 4100 site. Anyone who favors the county adopting all-county voting should write a letter of support to Staci.

RC pointed out sign placement issues, KH says RC should feel free to discuss with Staci.

KH says he is trying to build a long-term organization that will be self-sustaining and “live forever.” A lot of information has been made available, and precinct chairs and captains need to recruit volunteers! Our main purpose is to find all the Democrats in Kendall County and get them to the polls. KH invites new ideas going forward.

KH discusses difference between precinct chairs and captains.

Review and Approve GOTV Goals and Action Plan - LB

Laura discusses documents available on Google Drive, link sent out to the group. Training materials prepared by the state party are available, including a new module for precinct chairs. LB presents the Precinct Chair Manual and goes through its sections.

Kevin states that National Registration Day is 4th Tuesday in September (9/25/18).

Laura states we will be able to check VAN halfway through the early voting period to see who has not voted. During the election season, VAN should be updated every night. Laura will be conducting VA training in the office, contact her to schedule and bring your iPad or laptop.

Julie suggesting manning a voting registration table at new teacher orientation, and coordination with union representatives. She states that government teachers are generally good at getting young adults to register.

Commitment to Vote Form - KH

Kevin discusses use of commitment cards during GOTV canvassing, a two-part form and a reminder to vote will be sent out by the state party. Need to make sure we cover new neighborhoods. BO mentions use of Next Door App to connect with Democrats.

Slate Card/Approve Printing Cost – KH

He wants canvassers to have a Commit to Vote form and a Slate Card informing voters about the slate of candidates.

Peggy points out that some places the houses are not close to each other and block walking is not feasible, probably will have to use mail to provide the materials to residents. Judy says she will look into bulk postal rates at the USPS.

Kevin wants to order printing of 5,000 slate cards, at a cost of about \$400. **APPROVED** by unanimous vote.

Hustle, Voter Circle and Social Media – KH

Discussion of Hustle and Voter Circle. Dems are getting texts from Beto through the Hustle program – costs the campaign 5 cents per text. Brooke says she was not impressed with the program, problems with data accuracy. Voter Circle allows you to go through the directory by name and find the Democrats in your precinct.

Suggestion that large signs be placed in key intersections – reminding voters to register. Discussion of getting T-shirts made that say “Your Friendly Neighborhood Democrat.” Also suggested that taking a dog loosens people up and attracts attention.

Thoughts on Being a Precinct Chair - JJ

Julie stresses the importance of networking with the other PCs and meeting the Democrats in your precinct in person.
